



## C. Tax Forms and Income Information

All tax filers must submit a **signed** copy of all 2009 Federal Income Tax returns for yourself and spouse if married. This includes the 2009 IRS Form 1040, 1040A, 1040EZ, a tax return from Puerto Rico or a foreign income tax return.

If you did not keep a copy, call the IRS at 1-800-829-1040. Press "2- Refund or Personal Tax Account" then Press "2 – Personal Tax Account", follow the instructions until given the option to select a "tax return transcript" then follow the instructions.

Check the box for those **people who did not and are not required to file a 2009 Federal Income Tax Return**. List below your employer(s) and any income received in 2009 (use W-2 forms or other earning statements).
