

Standards of Conduct



GENEVA COLLEGE

Geneva seeks to develop in all students those Biblical qualities essential to a successful life: proper thoughts, attitudes and motives. It is important that each person learns to think and act in a manner pleasing to Christ, that each person learns to cooperate and work harmoniously in groups, that each person learns when to stand alone and knows when to defer to the opinions of others, and that each person seeks to glorify and enjoy God.

As members of a college community, we accept certain standards as essential to the accomplishment of our corporate mission. If viewed negatively, these standards limit the freedom of the individual. When considered positively, they provide reasonable boundaries within which freedom can be exercised by all, without compromising the rights of others. It is expected that students will abide by the standards set up by the Geneva College community, in both spirit and behavior.

An atmosphere congenial to Christian education results primarily from the establishment of academic and co-curricular opportunities consistent with Christian concepts and ideals. In addition, an atmosphere conducive to Christian growth is enhanced by certain standards.

The College requires members of its student body to abstain from immoral behavior, hazing, membership in social fraternities, the use of profanity, gambling and from the possession, sale, use or influence of illegal drugs or alcoholic beverages while under the jurisdiction of the College; i.e., on College property, at College sponsored events or on College sponsored trips. The use of tobacco, in any form, is prohibited in College buildings and throughout the campus. By action of the Board of Trustees, Geneva College is a smoke-free campus. Social or ballroom dances are not sponsored by the College. Students are expected to practice discretion and restraint, and honor the standards of the College in all areas, including a sensitivity and concern for the convictions of others in the choosing of TV programs, music, movies, printed materials, card games, folk and interpretive dance, dramatic productions, and other public or private programs. It is felt that these standards are in the best interest of the campus community, and students are expected to uphold these standards at all times. Disruptive activities jeopardizing the safety of students or the community are also prohibited and participation in such activities will subject a student to disciplinary action.

A handbook issued to all students explains such regulations in more detail and outlines the membership and procedures of a Judicial Committee, which reviews infractions of the rules and imposes sanctions. The College has the right at the end of an academic term to deny the re-enrollment of any student when in the opinion of the College such action is deemed to be in the best interest of the College and/or the student.
