Geneva College requires participants and their parents to acknowledge that the College cannot assume responsibility for such risks by signing this release. While there have been no serious mishaps associated with the Geneva College camps, it is important for participants and their parents/guardians to realize that risk is involved and to make an informed decision when participating in Geneva College camps.

2. <u>Insurance:</u> I understand that my camper is required to have health, accident and hospitalization insurance during his/her participation in the camp. Proof of insurance coverage must be furnished at the time of application(Initial)
3. Medical Treatment: In the event of illness or injury, I authorize any official representative of
Geneva College to secure medical treatment on my camper's behalf, including surgery and
administration of an anesthetic, and I accept financial responsibility for such treatment. I authorize any
physician, clinic, or hospital to furnish Geneva College all information related to my campers treatment.
I understand that while this authorization permits Geneva College to secure medical treatment on my
campers behalf if I am unable to do so, it in no way obligates Geneva College to do so. I further agree
that Geneva College and its representatives have no responsibility for, and shall be released from any
claim or liability relating to any injury or damage, which may arise out of or in connection with such
